



## Contact Tracing Privacy Notice

We are The Orchard Partnership, a well-established GP Practice. Our General Practitioners and allied healthcare professionals provide primary medical care services to our practice population and are supported by our administrative and managerial team in providing care for patients.

This privacy notice explains how we use any personal data we collect about you as part of The Orchard Partnership's COVID19 contract tracing process.

### [How do we collect your personal data?](#)

We will collect your personal data when you provide it to us when you arrive at the practice.

### [What types of personal data do we collect about you?](#)

We will collect the following types of personal data:

- Your name
- Your contact details (phone number, email address or home address)
- Date of visit and arrival and departure time
- Details of any COVID19 related symptoms

### [How will we use the personal data we collect about you?](#)

We will use your personal data in the following ways:

- To contact you following a confirmed COVID19 outbreak at The Orchard Partnership
- To support NHS Test and Trace in England

Any medical or health related personal data will be treated with confidence and in line with the Common Law Duty of Confidence.

### [How will we share your personal information?](#)

We will share your information with the Department of Health & Social Care to support NHS Test and Trace in England.

### [How long do we keep your personal data](#)

We will hold your personal data for 21 days.

## Legal Basis

The processing of your personal data is necessary for the performance of The Orchard Partnership official tasks carried out in the public interest in providing and managing a General Practice service and the processing is also necessary for reasons of public interest in the area of public health.

In some circumstances, we may process your personal information on the basis that:

- we are required to do so in order to comply with legal obligations to which we are subject;
- in the establishment, exercise or defence of a legal claim;
- or
- you have given us your explicit consent to do so.

## Your rights

You have a right to:

- access the information we hold about you;
- correct inaccuracies in the information we hold about you;
- withdraw any consent you have given to the use of your information;
- complain to the relevant supervisory authority in any jurisdiction about our use of your information; and
- in some circumstances:
  - erase information we hold about you;
  - receive a copy of your personal data in an electronic format and require us to provide this information to a third party;
  - restrict the use of information we hold about you; and
  - object to the use of information we hold about you.
